

Tribute to Vietnam War Fallen Heroes Exhibit Unveiled in Santa Fe



More than one hundred Vietnam War veterans, family members, friends, and family members of Vietnam War veterans killed in action attended the unveiling of a *Tribute to New Mexico's Fallen Vietnam War Heroes* display today inside the Bataan Memorial Building in downtown Santa Fe.

The display honors the 398 New Mexicans killed in action during the Vietnam War. The photos are featured in four large frames in the main hallway leading to the New Mexico Department of Veterans Services (NMDVS), which hosted the ceremony.

Shortly before the photo tribute was unveiled, NMDVS Secretary Jack Fox reminded everyone that even though the war may have been unpopular with many here at home, the fallen soldiers nevertheless answered the call to arms when our country came calling for their service.

"I want everyone to know...these young men did not die in vain. They died while serving our country with honor and distinction," said an emotional Secretary Fox, a former Deputy Adjutant General in the New Mexico Army National Guard was on active-duty status during the war. "They died while fighting an evil force. It is therefore up to us here today...and our future generations...to make sure that their ultimate sacrifice will never be forgotten."





58,200 American service mem-

bers lost their lives in combat during the Vietnam War.

The photos of the fallen 398 New Mexicans were collected by the Vietnam Veterans of America/Northern New Mexico Chapter 996. In 2009, the non-profit service organization took the lead in New Mexico when the Vietnam Veterans Memorial Fund (VVMF) launched a nationwide *Call For Photos* Project to gather photos of all American service members killed in action in the Vietnam War.

Four years later, New Mexico became the first state to collect photos of all of its Vietnam War KIA's. The VVMF, which operates the national Vietnam Veterans Memorial Monument/Wall in Washington, D.C., will feature all collected photos in a digital display at a national Vietnam Veterans Memorial Museum to be built next to the national Memorial Wall.

Vietnam War-Era Veterans Honored at Special Ceremony in Artesia



Southeastern New Mexican Vietnam War-era veterans were honored on April 28 at a 50th Anniversary of the Vietnam War Commemoration Ceremony in Artesia. More than 150 Vietnam War-era veterans and family members of deceased Vietnam War-era veterans attended the ceremony, which was presented by the New Mexico Department of Veterans Services (NMDVS) and the city of Artesia--along with assistance from the New Mexico State Council of the Vietnam Veterans of America, the New Mexico VA Health Care System, the Las Cruces Vet Center, and the Santa Fe National Cemetery.

The ceremony was presented as part of an ongoing nationwide initiative launched by the Department of Defense (DoD) in 2008 urging states to honor America's Vietnam War veterans. A year later, this effort was extended through 2025. The NMDVS has been designated by the DoD as the official "lead" in the commemoration effort in New Mexico.

"During the Vietnam War, our returning service members were greeted with silence — or worse yet, by a public not supportive of our service members serving in a war which sharply divided our country," said NMDVS Secretary Jack Fox in his Welcome Address. "But history now shows us these men and women served with honor, dignity, and bravery when our nation came calling for their service. Today, we say 'Welcome Home — and thank you for your service and sacrifice."



All Vietnam War-era veterans and family members of deceased

Vietnam War-era veterans were presented with a certificate of appreciation for their service during the war, and a special 50th Anniversary Commemorative Pin. More than nine million Americans served in the military during the Vietnam War. Of the 58,000 Americans killed in battle, 398 of them were from New Mexico. Today, nearly 60,000 Vietnam War veterans live in New Mexico. More than a thousand have been honored since the NMDVS began this commemoration effort last year. Additional ceremonies are planned in other communities in the coming years.

Bataan Remembrance Day Observed in New Mexico

The 75th anniversary of the infamous Bataan Death March of World War II was observed at ceremonies in Santa Fe, Albuquerque, Las Cruces, and Grants last month.

On April 9, the New Mexico National Guard held its annual Santa Fe tribute at the Eternal Flame Monument in front of the Bataan Memorial Building. Members of the New Mexico National Guard Color Guard lowered the American Flag—and raised a white "surrender flag" to commemorate the day 75 years ago—April 9, 1942-when Allied forces surrendered to Japan on the Bataan Peninsula in the Philippines. On that date, U.S. General



Edward King ordered his troops to surrender to the much larger and better-equipped Japanese force. More than 75,000 Allied soldiers were taken prisoner, including 1,800 members of the New Mexico National Guard—which had been six months into a training exercise when Japan attacked.

The prisoners were then forced to march sixty torture-filled miles to prison camps. Many died or were executed along the way. Those that survived the march, which became known as the *Bataan Death March*, then endured 3-1/2 years of brutal imprisonment. Less than half of the New Mexicans were alive by the time Japan surrendered on September 2, 1945—thus ending World War II.

New Mexico Department of Veterans' Services Deputy Secretary Alan Martinez had the honor of reading the official Bataan Remembrance Day Proclamation issued by Governor Susana Martinez, who was unable to attend due to a previously scheduled commitment.

"I hereby proclaim today as Bataan Remembrance Day throughout the state in honor of the brave New Mexicans who suffered in the name of freedom," read Deputy Secretary Martinez. "America will forever remember these Heroes of Bataan. We will always be in awe of how they relied on their extraordinary strength and spirit to survive— enduring tremendous suffering so that we would remain free."

NMDVS Secretary Jack Fox was the featured speaker at the Las Cruces ceremony. He echoed the

Governor's sentiments, praising the Defenders of Bataan as "true American heroes...in every sense of the word...whose sacrifice paved the way for freedom not only for America, but for the Philippines...and all of Asia."

Monument Honoring American Military Families to be Dedicated in Santa Fe



The Museum of the American Military Family invites the public to a dedication of a monument honoring American military families on May 13 at 1pm in Santa Fe at the New Mexico National Guard Museum (formerly the Bataan Memorial Museum), located at 1050 Old Pecos Trail.

The memorial is a small house, designed by Museum of the Military Family Executive Director Dr. Circe Olson Woessner. It is dedicated to mothers and

fathers, sons and daughters, spouses, and others who have loved and supported a member of the U.S. Armed Forces. Through each of five windows, visitors can view displays depicting the life of a military family—offering a glimpse into the lives of a typical military family.

"I don't know if there are any other memorials dedicated to the military family," said Dr. Woessner. "I am grateful that the National Guard leadership recognizes the family as an essential component of military service."

Staff from the VA and the NMDVS trained the tribal representatives to help with filing claims for VA and state veterans' benefits. The goal, said NMDVS Secretary Jack Fox, is to serve Native-American communities far from NMDVS offices. A secondary benefit, he added, is to make the process easier.

"Many feel more comfortable talking with someone



familiar with their own language and customs," said Secretary Fox. "So we invited VA training officials to train representatives from tribal communities, because we want more Native American veterans to get the veterans' benefits they've earned through their military service."

VBOC Success Story: One Community Auto LLC



A veteran-owned business which received start-up counseling and assistance from the New Mexico Veterans Business Outreach Center (VBOC)—the business development division of the New Mexico Department of Veterans Services—has been selected as a winner of the 2017 American Small Business Championship.

One Community Auto LLC of Albuquerque was chosen as one of 102 nationwide winners by SCORE—the nation's largest network of volunteer business mentors which helps small business owners in America--which also collaborated with Sam's Club for this nationwide contest.

Gary Peterson One Community Auto LLC

The company was founded by Albuquerque native and retired U.S. Air Force Major Gary Peterson, and was one of only two companies from New Mexico to receive the award. One Community Auto LLC assists non-profit organizations by refurbishing their donated used cars and re-selling it for them at its lot not far from Kirtland Air Force Base—where

Mr. Peterson was formerly stationed.

Entrants submitted an online application describing the most unique aspect of their small business that has contributed to their success, and how it positively impacts the community. *Nominations which* garnered at least 100 votes were then presented to a judging panel of small business experts to determine the winners. It was this aspect of re-selling on behalf of non-profit organizations which, according to Mr. Peterson, most likely impressed the judges.

"This not only saves the car from the junk yard, it end up also benefitting organizations which help citizens in need here in the community," said Mr. Peterson. "Other programs send vehicles to auction--but we save the vehicles and give them new life."

He also thanked the VBOC and other agencies for helping him realize a long-held dream of opening his own company.

"I couldn't have launched my business without the help of the VBOC, the SBA, SCORE, the New Mexico Small Business Developments Centers, WESST, and other local resources," said Mr. Peterson. "I had the passion and the drive, but not the business sense. They helped me put my business plan together and then launch and grow One Community Auto."

All 102 winners receive a \$1,000 Sam's Club gift card, an all-expense-paid trip to a training and networking event, SCORE mentoring, and free publicity throughout the year. One Community Auto is now eligible to win one of three \$25,000 grand prizes awards as one of three national Grand Champions this fall.

The flag was flown at Camp Lemonniere, the U.S. Naval Expeditionary Base in Djibouti which serves as the primary base of America's military operations in Africa. It was given to the group Women Veterans of New Mexico and serves as a "Traveling Flag" which the group takes to all of its activities.

DoD Releases Annual Report on Women Serving in the U.S. Armed Forces



The U.S. Department of Defense's Defense Advisory Committee on Women in the Services (DACOWITS) released its annual report on matters relating to women serving in the Armed Forces of the United States for Fiscal Year (FY) 2016.

DACOWITS provides the Department of Defense (DoD) with advice

and recommendations on matters and policies relating to the recruitment and retention, treatment, employment, integration and well-being of highly-qualified professional women in the armed forces.

Each December, the committee selects several study topics to examine during the following year. For 2016, DACOWITS studied 14 topics. The committee gathered information from multiple sources in examining these topics; for example, briefings and written responses from the DoD, service-level military representatives, and subject matter experts; data collected from focus groups and interactions with service members during installation visits; and peer-reviewed literature. DACOWITS collected qualitative data during their visits to multiple installations—representing all four DoD Service branches (Air Force, Army, Marine Corps, Navy) and the Coast Guard.

Based upon the data collected and analyzed, the FY16 annual report includes 14 recommendations and four continuing concerns the committee made to the secretary of defense on the following topics: Mentorship, single-parent waivers, accessions and marketing, the chaplain corps, gender integration, combat gear and equipment, pregnancy and parenthood, physical standards, strategic communications, transition services, and sexual harassment and sexual assault training. VA Implements Digitizing Process of Older Files Which Should Save Claims Times, Taxpayer Money

For information about VA health care, visit the website of the New Mexico VA Health Care System at: www.albuguergue.va.gov The Department of Veterans Affairs (VA) recently started digitizing older, inactive paper records, which VA officials said will save claims times—and taxpayer dollars through reduced, leased office-space that currently houses these records.

"This is just one of the ways in which we are modernizing our capabilities, not only to be more responsive to Veterans and their families, but also to be good stewards of taxpayer dollars," said VA Acting Under Secretary for Benefits Thomas Murphy.

This new "paper-extraction" process ensures that when a claim is filed, a veteran's electronic record is already available in the VA's computer systems, reducing processing time for benefit claims from veterans and their survivors.

In the past, when a veteran filed a new or supplemental claim, if a medical condition had worsened, the retired paper files were boxed and shipped to a central site to scan into the VA's systems before work would begin on the new claim.

Nearly 2 million inactive files were housed in 33 regional offices across the country before the change. As of April 14, more than 500,000 files have been collected from eight regional offices for scanning. Once the records have been digitized, the VA will archive and store them in less expensive long-term storage for safekeeping.

The agency plans to remove and scan paper claim records from the remaining regional offices by the end of 2018.

"This modernization initiative seeks to eliminate delays caused by shipping and digital conversion," said Bradley Houston, director of the VA's Office of Business Process Integration, which oversees the initiative. "It will give claims processors nationwide the ability to instantly access millions of inactive claim records when needed."

Over the past five years, the VA has made concerted efforts to modernize the way it processes compensation and pension claims. Since 2012, 397 million records — consisting of 2.6 billion images — have been scanned, indexed and uploaded into the agency's electronic-claims processing system, Veterans Benefits Management System. In fiscal 2016, the VA provided compensation and pension benefits to more than 5.1 million veterans and family members, totaling over \$80 billion.

VA to Begin Offering Mental Health Care to Veterans with "Bad Paper" Discharges

The U.S. Department of Veterans Affairs (VA) will begin making mental health care services available to veterans with less-than-honorable discharges who urgently need it.

"We are going to go and start providing mental health care to those with other-than-honorable discharges," said VA Secretary David Shulkin after he testified before the House Committee on Veterans' Affairs on planned changes at the VA. "I don't want to wait. We want to start doing that.

Discharges that are other-than-honorable, including a "general" discharge, are known as "bad paper" and can prevent veterans from receiving federal benefits, such as health care, disability payments, education and housing assistance.



Lawmakers and veterans advocates have said service members with bad paper were, in many cases, unjustly released from the military because of mental health issues. They estimate 22,000 veterans with mental illnesses have received other-than-honorable discharges since 2009.



The plan was announced in response to a question during the hearing about Secretary Shulkin's plans to prevent veteran suicides. In addition to providing care to veterans with bad paper, the VA secretary also told lawmakers that he wanted to hire approximately 1,000 more mental health care providers.

"Our concern is those are some of the people that right now aren't getting the services and contributing to this unbelievably unacceptable number of veterans suicides," said Secretary Shulkin.

He said he's notifying medical centers about the change and that he'd like to implement a program sometime in the next few months.

Kristofer Goldsmith, president of High Ground Veterans Advocacy, has fought for years for discharge upgrades for veterans with bad paper. After hearing from officials with military review boards during a congressional hearing last week, Goldsmith said the Defense Department "isn't doing anything proactive to help."

Goldsmith, along with the group Vietnam Veterans of America – where he also works, has asked President Donald Trump to pardon all post-9/11 veterans who were administratively separated from the military and did not face a court-martial. The White House said it will study this request.

NMDVS Health/Safety Tip: Spring: Time to Review Your Home Safety Checklist

With spring comes a feeling of renewal. Families everywhere begin cleaning out their basements and garages. Windows are opened, flowers bloom and the days grow longer thanks in part to Daylight Saving Time, which this year began on March 13.

When you set your clocks forward, the National Safety Council reminds you also to review a safety checklist for your home.



Smoke Alarms

Smoke alarms save lives – if they are powered by a fresh battery. You should test them every month to make sure they work and replace the battery at least once a year, according to the National Fire Protection Association. If the alarm makes a "chirping" sound, replace it immediately.

Smoke alarms should be located in every bedroom and in the common areas on each floor of a home. Mount

them at least 10 feet from the stove to reduce false alarms, less than 12 inches from the ceiling and away from windows, doors and ducts.

Did you know smoke alarms can be interconnected wirelessly? That means, when one sounds, they all sound. A Consumer Product Safety Commission survey found this is the best way to notify everyone in a home if there is a fire. Be sure to purchase smoke alarms with the label of a reputable testing agency, like Underwriters Laboratories (UL).



Three out of every five home fire deaths resulted from fires in homes with no smoke alarms, according to NFPA.



Carbon Monoxide Detectors

Carbon monoxide (CO) is an invisible, odorless gas, and it can kill you. Anything in the home that burns fuel can potentially become a source of carbon monoxide. CO alarms should be installed in a central location outside each bedroom and on every level of the home.

The safety tips for CO detectors mirror those of smoke alarms: change the batteries, test them and interconnect them, if possible.

Also, make sure vents for your gas appliances (fireplace, dryer, stove and furnace) are free and clear of snow or debris.







Family Emergency Plan

The National Safety Council recommends every family have an emergency plan in place in the event of a natural disaster or other catastrophic event. Spring is a great time to review that plan with family members to make sure they know what to do.

Have a home and car emergency kit. The Federal Emergency Management Agency says an emergency kit should include one gallon per day of water for each person, at least a three-day supply of food, flashlight and batteries, first aid kit, filter mask, plastic sheeting and duct tape, and medicines. Visit the FEMA website for a complete list.





The emergency plan also should include:

A communications plan to outline how your family members will contact one another if they are not in the same place and where you should meet if it's safe to go outside.

A shelter-in-place plan if outside air is contaminated; FEMA recommends sealing windows, doors and air vents with plastic sheeting. A getaway plan including various routes and destinations in different directions

Discard Expired Medicine

NSC recommends you take unwanted or expired medicines to a prescription drop box or take-back event near you. Serious consequences may result if you take medicine past its expiration date—expired medicine may not be at the strength needed for any medical conditions or emergencies.

The easiest and best way to update your home medicine kit is to make sure you have "fresh" prescription medicines and fresh aspirin/Tylenol/ibuprofen, allergy medicine, cough syrup, or any other over-the-counter medicines you frequently use over the course of a year.
