Retired NM Air National Guard BG Judy Griego Confirmed as DVS Cabinet Secretary

Retired New Mexico Air National Guard Brigadier General Judy M. Griego was unanimously confirmed by the New Mexico Senate on February 6 as Secretary of the New Mexico Department of Veterans' Services (DVS). She was appointed to the position by Governor Michelle Lujan Grisham on December 27.

"I am thrilled that the Senate agreed with me that General Griego has the management experience and leadership skills necessary to lead the Department of Veterans Services," said Governor Lujan Grisham after being informed of the Secretary Griego's confirmation. "She has a passion for helping the men and women who have served our country. She has a way of connecting with them. I am confident she will do an excellent job leading DVS."

Secretary Griego had a distinguished 36-year military career, retiring in August of 2016 at the rank of Brigadier General—the first woman to be promoted to the rank of General in the history of the New Mexico National Guard. She began her military service in 1979 by enlisting in the New Mexico Air National Guard. She worked her way through the enlisted ranks—attaining the rank of Master Sergeant. In 1991, she was commissioned as a Second Lieutenant upon graduation from the Academy of Military Science at McGhee-Tyson Air Force Base in Knoxville, TN. In 2007, then-Lt. Col. Griego was deployed to Balad Air Base Iraq to serve in key leadership positions in support of Operation Iraqi Freedom. Her rise through the officer ranks culminated with her historic promotion to Brigadier General on December 1, 2011.

During her military service, Secretary Griego earned a Bachelor of Science Degree in Professional Aeronautics and a Master of Science Degree in Aeronautical Sciences from Embry-Riddle Aeronautical University.

"As a native New Mexican, I am humbled to be given this chance to serve my state's veterans and their families," said Secretary Griego. "I have seen the incredible sacrifice they've made to serve our country. This is a persona mission for me. The DVS staff and I will work hard to help veterans receive every VA and state veterans' benefit to which they're entitled—and will work to find ways to further improve their lives."

Each state has a VA State Approving Agency Director to ensure that colleges and training programs adhere to strict standards set by the VA for education and training programs available for veterans through the GI Bill®.

The annual conference provides the NASAA with the opportunity to inform Congress and other national leaders of its goals and concerns related to its mission of protecting the Education Benefits Bill—more commonly known as the GI Bill®.

One of the most recent landmark achievements of the NASAA and its members was its work in helping Congress pass the Colmery Act—or the “forever” GI Bill®. President Donald Trump signed the bill into law in 2017—which, foremost among other new changes, removed the time limit veterans have to use their GI Bill®. Recent veterans and new service members will be able to use their GI Bill® forever.

Bataan Death March Survivor Joe Romero Passes Away

World War II Bataan Death March Survivor Joe S. Romero passed away on January 26 in Albuquerque. He was 98 years old. Mr. Romero was laid to rest with full military honors at Sunset Memorial Park.

The Las Cruces native was 19 years old when he enlisted in the New Mexico National Guard in 1941. He was one of 1,800 Guard members of the 200th Coast Artillery Unit in the middle of a training exercise in the Philippines when Japan launched a surprise attack on that country on December 8, 1941—just hours after its Pearl Harbor attack. The men were immediately activated for combat, and became part of a small force of existing American and Filipino service members waging a defense against the much larger and better equipped Japanese force.

Four months later and facing what he deemed a certain defeat, U.S. Army Maj. Gen. Edward King, the Commanding General of the Philippine-American forces on the Bataan Peninsula, ordered his 75,000 Allied soldiers to surrender on April 9, 1942.

Mr. Romero and most of the prisoners were forced by their Japanese captors to march more than 60 miles to prison camps in what has come to be known as the Bataan Death March. An estimated 10,000 died during the march. Mr. Romero was initially held at the Cabanatuan Prison Camp, where many prisoners were worked to death making a runway that was eventually bombed by American planes. He and a thousand other prisoners were then crammed aboard the *Hokusen Maru* “hell ship” to brutal prison labor camps in Formosa and Japan—forced to work in dangerous lead and zinc mines.

In September of 1945, Mr. Romero was freed after Japan surrendered to the United States. Though weighing a mere 110 pounds, he was still very strong in spirit and desire to come home to New Mexico. Settling in Albuquerque, Mr. Romero and wife Josephine started a family. He went on to work for many years in the menswear department at Levine's Department Store.

Mr. Romero is survived by daughter Ana Marie Gonzales of Albuquerque. With his passing, only seven remain from the original 1,800 New Mexico National Guard's Defenders of the Bataan Peninsula.

VA to Launch Major Overhaul of Claims Appeals Process

Hundreds of thousands of veterans, some of them trapped indefinitely in a complex system of trying to obtain benefits from the Department of Veterans Affairs, will get new options next week promised to deliver decisions in days or months, instead of years.

The VA is set to implement a new process Tuesday for veterans to appeal their claims for VA disability compensation - a system devised by the VA, veterans organizations and lawmakers and approved by Congress in 2017. Under the current system, veterans wait three to seven years to reconcile their appeals. The new one could get veterans through the process in as little as 125 days, VA officials vowed.

"This is the biggest change to appeals for decades," said Cheryl Mason, chairman of the Board of Veterans' Appeals. "It was designed to give veterans choice and control over their process instead of getting stuck like they do now. VA realized that veterans were confused by the process, that it was a complex system and that it simply took too long."

The new system involves multiple avenues for veterans, including an option to appeal their claims with a higher-level adjudicator or directly with the Board of Veterans' Appeals. Another option is to add information to their claim and appeal it with the same adjudicator who reviewed it.

David McLenachen, director of the VA's appeals management office, said the VA will track the amount of time it takes veterans to get through each option. The agency will make that information public to help veterans decide which route to take, he said. With the new process, VA officials have the goal of cutting down the backlog of appeals, which stands at 402,000 cases.

The VA has hired 605 new employees in the past four months to help with claims. For over a year, the VA has operated a pilot program to test the new system. Through the program, titled the Rapid Appeals Modernization Plan, or RAMP, veterans with appeals stuck in the old system were allowed to opt into the new one. Over that time period, about 70,000 veterans with 84,000 claims opted in. The VA had granted decisions on 70 percent of those claims as of Thursday and gave out nearly \$250 million in retroactive benefits, McLenachen said. On average, it took 130 days to get veterans their decisions.

The RAMP pilot program ended on February 15, ahead of the new system launching nationwide next week. In a statement on February 14, VA Secretary Robert Wilkie encouraged veterans with appeals stuck in the old process to opt in by the 15th. Otherwise, they must wait to opt in to the new system until the VA sends them a statement of their pending claim.

The VA is expected to hold an event on February 19 to launch the system.

VA, DoD Working to Create Single E-Record System

The Departments of Defense and Veterans Affairs are still trying to figure out how to best align their agencies' respective plans to create a common Cerner electronic health record system.

Speaking February 13 at the HIMSS19 conference in Orlando, DoD and VA program officials said coordinating their activities to ensure interoperable EHR systems is a work in progress, emphasizing that the agencies continue to discuss an optimal organizational design that will facilitate coordinated decision-making and oversight when it comes to governance. Toward that end, the DoD and VA Interagency Program Office is working to establish joint EHR modernization governance bodies to foster coordination and improve communication between the departments.

"We can't talk enough about the work that the Interagency Program Office has done to ensure that the DoD and VA are aligning around commercial standards and to also be able to provide a consolidated input between basically the two largest federal healthcare providers," Stacy Cummings, program executive officer for Defense Healthcare Management Systems, told a HIMSS audience.

Cummings noted that late last year Defense Secretary James Mattis and VA Secretary Robert Wilkie signed a joint statement committing to the implementation of a single, seamlessly integrated EHR that "maximizes commercial health record interoperability" by sharing data between the two agencies as well as community healthcare providers. The purpose of the document signed by Secretaries Mattis and Wilkie was to "demonstrate the commitment of both the DoD and the VA to the success of this electronic health record deployment," according to Cummings. To make decisions and execute them jointly, she added that the agencies have put together a working group to create synergies and efficiencies.

"We're making great progress—we're looking at risk and technical and programmatic functions," she said. "Having greater synergy will reduce the risk to both of our programs."

Last year, the VA awarded Cerner a \$10 billion EHR modernization contract—one of the largest IT contracts in the federal government—to replace the agency's decades-old Veterans Health Information Systems and Technology Architecture. In 2015, DoD awarded a \$4.3 billion contract to prime contractor Leidos to modernize the military's EHR system with Cerner's Millennium platform. According to Cummings, the two agencies will share a data center hosted at Cerner's Kansas City headquarters in a "single instance" enclave, with the VA taking advantage of investments DoD has already made in that commercial data center.

"DoD has already gone live at facilities—we are still educating our clinicians, and that's a tough chore," said John Windom, executive director of the VA's Office of EHR Modernization, at the HIMSS19 conference. "We want to make sure we're judicious in the way we move forward such that our change management strategies that we're both employing will take hold as appropriate. This is about the end user—the person that's required to use Cerner Millennium."

"It's a hard sell because people are used to what they're used to, regardless of how arduous it may be to use or how cumbersome," added Windom, referring the VA's legacy VistA system which is popular with the agency's clinicians.

At the same time, Windom pointed out that DoD and VA have "two different patient populations" that the agencies are trying to both serve using a single, seamlessly integrated EHR. "That's a tremendous challenge that we don't take lightly," he concluded.

NMDVS FIELD OFFICES

The New Mexico Department of Veterans Services has thirteen field offices to assist veterans and their eligible dependents with filing for VA and state veterans benefits. Each office is managed by a nationally certified Veterans Service Officer (VSO)—who are also veterans themselves.
