Veterans Day Celebrated Throughout the State



Santa Fe Veterans Day ceremony at the city's Veterans Memorial

Veterans Day was celebrated throughout the state on November II—and in some cases, a few days before or after the date—as communities resumed celebrations a year after events were cancelled due to the onset of the COVID-19 pandemic.

In Santa Fe, New Mexico Department of Veterans Services (DVS) Cabinet Secretary Sonya Smith was a guest speaker at the city's annual Veterans Day ceremony at the Santa Fe Veterans Memorial.

Secretary Smith joined keynote speaker Congresswoman Teresa Leger Fernandez, Santa Fe Mayor Alan Webber, and Maj. Gen. Ken Nava, the adjutant general of New Mexico, in honoring the service and sacrifice of veterans for our nation.

"As we pause to honor our veterans today, let us also take a moment to thank our veteran and military families," she said. "The spouses and children of our military are the thread that keeps our armed forces quilt together."

The secretary referenced a quilt by members of the Santa Fe Quilts of Valor presented to a veteran in gratitude for his work in Santa Fe's veteran community. The secretary added that about 430,000 military families relocate every year—posing hardships for the military family unit.

The ceremony was presented by the city of Santa Fe and the city's veterans advisory board—with help from Vietnam Veterans of American/Northern New Mexico Chapter 996,VFW Post 2951, American Legion Posts I & I2, the American Legion Auxilliary, and the New Mexico Department of Veterans Services.

DVS Co-Hosts Two-Day Veterans Day Film Series in Santa Fe

DVS, Warrior Films, and the Jean Cocteau Cinema presented A Veterans Journey Home two-day film series on Veterans Day at the historical downtown Santa Fe theater.

Filmmaker Frederick Marx presented five films: Solutions, Ben's Story, On Black Mountain, Kalani's Story, and Leaving It On The Land—each film telling a story of readjustment by combat veterans back home from the battlefield.



"We are very proud to bring these stories to you," said DVS Cabinet Secretary Sonya Smith during a Veterans Day evening pre-screening reception (top photo). "These films show us some incredible journeys which we think can inspire other veterans who might be facing the same situations."



U.S. Senator Ben Ray Lujan also attended Thursday's evening reception, where he thanked Marx for shining a positive light on the readjustment struggles facing many returning combat veterans.

The senator also presented a copy of the Congressional Record to World War II veteran Bennie Montoya of Santa Fe (*left photo*), who attended the reception. The document, which is the official daily record of the proceedings when Congress is in session, documents the day this summer when Senator Lujan honored Montoya by speaking about him on the senate floor on the veteran's 100th birthday.

DVS Helps Organize Pre-Veterans Day Parade at the State Veterans Home

On November 6, DVS, New Mexico State Police, and the New Mexico Department of Health collaborated to organize a special pre-Veterans Day parade to honor residents and staff of the New Mexico State Veterans Home in Truth or Consequences.

The noon parade featured 63 vehicles from law enforcement and first responder agencies from throughout the state—along with more vehicles and motorcycles from veterans service organizations. Residents who were physically able to make it outside sat in chairs as the law enforcement and first responder vehicles drove by—most with sirens pulsing and lights flashing. DVS Secretary Sonya Smith and DVS Event Coordinator Joseph Dorn, one of the main coordinators of the parade, rode in a vintage New Mexico State Police car.





"The months of planning...the phone calls. zoom meetings and emails...when I saw the looks and reactions from the veterans, it was all worth it," said Mr. Dorn. "We are all proud to be able to do this for them. They deserve recognition on Veterans Day."

"I thought it was great," said 89-year old Korean War veteran Joe Eiken. "They're saying hello...and kinda saying they appreciate us. I

thought it was really nice...yeah."

Prior to the parade, DVS gave each resident a warm fleece blanket (right photo), a DVS agency pin, a New Mexico veterans lapel pin, and a note from DVS Cabinet Secretary Sonya Smith thanking them for their service and sacrifice for our country.

Two DVS VSOs Help Veterans Receive Claims—With Back Pay

DVS Veterans Service Officers (VSOs) Dagmar Youngberg and Danielle Thompson each helped a veteran in their community file claims resulting in the recovery of a substantial amount of back pay from VA.

Ms. Youngberg, based in the DVS Carlsbad office, helped a veteran recover \$738,000 last month. The veteran (note: DVS will not name the veteran, out of respect for his/her privacy) made an appointment in March to see Ms. Youngberg—wanting to re-open an old claim...not sure why, after completing military service 20-years ago, he/she has been denied benefits even after three enlistments. Ms. Youngberg requested and received written permission to reopen the claim and do a "deep dive" into his/her military

records.

"I noticed the last of the three enlistments resulted in a less-than-honorable discharge, meaning this veteran could not receive VA benefits," said Ms. Youngberg. "But I also noticed the veteran's two previous enlistments ended with honorable discharges. It became clear to me that the original claim was incorrectly processed, and that this veteran should've been receiving VA health care benefits all these years—and could probably claim back pay."

Ms. Youngberg also realized that re-filing a new claim would've only resulted in back-pay granted from the new re-filing date. So she contacted Albuquerque VA Regional Officer (VARO) Change Management Agent Cris Sheirer. After he helped order a new round of compensation and pension examinations, the veteran—and Ms. Youngberg—received word late last month: A rating of 100% permanent and total, service-connected disabled--including special monthly compensation. And the news she and the veteran were waiting for: Back pay covering the 20-years since the veteran originally filed a claim within a month after completing the third enlistment.

"I am thrilled beyond words that I was able to help this veteran get what the veteran has deserved all along," said Ms. Youngberg. "I'd like to thank Cris for his help. The veteran immediately paid off his/her mom's mortgage—on her birthday, no less. For this veteran, it also now means no more s truggling to get by on Social Security Disability Insurance payments (SSDI) and the Supplemental Nutrition Assistance Program (SNAP)!"

In Roswell, DVS VSO Danielle Thompson helped a veteran recover \$232,500 earlier this year as the result of a previously denied claim for presumptive health conditions related to the veteran's exposure to Agent Orange during the Vietnam War.

The passing of the Blue Water Navy Vietnam Veterans Act by Congress in 2019 allowed a presumption of exposure to Agent Orange to Blue Water Navy Veterans who served within 12 nautical offshore of the Republic of Vietnam to file beginning in January of 2020.

These "Blue water navy veterans" were now allowed to file presumptive exposure claims and appeal previously denied claims—with possible back pay for successful claims to the original file date of that was denied.

So Mrs. Thompson refiled another claim—along with records of the previously rejected claim as required by the VA. Once the VA Regional Office received the military records from National Personal Records in November 2020, they were able to request Compensation and Pension Exams

The veteran called her not too long ago--concerned about a large deposit in the veteran's bank account. So Mrs. Thompson contacted Mr. Scheirer at the VA Regional Office, who was able to confirm that the appeal was successful—with back pay going back 20 years.



"I was so stunned...and then really excited," she said. "This has changed the veteran's life, as you can imagine. The veteran was finally able to retire and do some long dreamed-of travelling with the veteran's spouse. I would like to thank the help of Mr. Scheirer with the Albuquerque VA Regional Office. It is such a great feeling knowing that we help make a difference in someone's life. This just really, really makes me happy."



DVS Cabinet Secretary Smith Attends Clovis Veterans Town Hall Meeting


She was invited by the post and American Legion State Commander Robert Rodriguez to give an update on DVS initiatives and plans.

At the top of the list—and despite bringing aboard three new veterans service officers (VSOs) last month, she said, is filling six more VSO vacancies.

"We just hired two VSOs in Las Cruces and one in Albuquerque," said Secretary Smith. "We are actively working on filling vacancies in Alamogordo, Grants, Hobbs, Raton, Silver City, and Taos. I want to make sure we have coverage for the whole state." (NOTE: DVS has since filled the Silver City VSO vacancy. See page 19 for details)

Secretary Smith said she also wants to work on something she says she's been hearing about ever since her confirmation nine months ago as DVS cabinet secretary.

Norfolk, VA. "I'm like...'What?' This has got to stop. We are all one. We are all veterans. We are all New Mexicans." Other topics discussed were the need for veterans to know more about veterans income levels and VA health care

'I was told that there is a disconnect here in New

thresholds, an increase in the stipend for honor guards, and adding a 2nd honor guard conference.

"This is something I brought up at this summer's annual honor guard training conference, which was met with a positive reaction," said Secretary Smith.

There is acritical shortage of doctors and urgent care in Clovis/Curry County, which was brought to the attention of Dr. Dalton Keel, Chief of VA's Lubbock-Levelland Community Based Outpatient Clinical Services, who was the other guest speaker at the town hall. He also oversees the VA Community Based Outpatient Clinic (CBOC) in Clovis.

"It's difficult for small towns like Clovis to attract doctors—this, we are acutely aware of," said Dr. Keel. "VA is having to incentivize to attract doctors to the Clovis CBOC. But we will keep trying to hire and then keep doctors here."

Dr. Keel also responded to a point made by a veteran in the audience who pointed out the lack of non-VA urgent care clinics in Clovis—preventing veterans from using VA's "Choice Act" to receive medical care at VA-approved non-VA facilities.

According to Dr. Keel, Presbyterian Plains Regional Medical Center and its clinics have stopped accepting VA Choice Act patients. DVS Cabinet Secretary Smith, who sits on the Presbyterian Health Care Foundation board of directors, assured Dr. Keel and the veterans in attendance that she will bring this matter up with the foundation.

"Thank you for bringing this to our attention," she told the audience. "We need to bring Presbyterian back to the table and talk about this."



DVS Helps Homeless Veterans at "Stand Downs" in Gallup and Farmington

Staff from the New Mexico Department of Veterans Services (DVS) were among the many state, federal, and local agency representatives providing assistance at "stand downs" for homeless veterans in Gallup and Farmington last month.

On October 7, DVS Veterans Service Officers (VSOs) Benjamin Stewart, Durrell Tsosie, and DVS Gallup State Veterans Cemetery Supervisor Gilbert Lopez were at the city of Gallup's 9th annual "*Project Stand Down & Hand Up*" stand down at Red Rock Park just outside Gallup. (top photo). The trio provided information about VA and state veterans benefits and programs—many of which the attending veterans were not using or were even aware of.

"It's a lot of misinformation," said Mr. Stewart. "They're approaching us, asking us what benefits they're entitled to, what they qualify for, and how they would go about applying for these benefits."

On October 8, DVS VSO Beverly Charley spent the day running the floor as the coordinator of the 9th Annual San Juan County Veterans Stand Down at the San Juan College Health & Human Performance Center. (right & bottom photos) It's a role she's served ever since she helped organize the first stand down along with the San Juan County Veterans Collaborative in 2012.

"This means a lot to me-- we know a lot of the veterans," said Ms. Charley, who like all DVS VSOs are

veterans themselves. "I served in the military for I4-years, and I work with veterans every day. I hear the stories—I hear a lot of the things that they're going through. I wouldn't want to be on that side of the road—that side of the desk. They are our brothers and sisters, if you really think about it."





Both stand downs provided hot meals, free clothing, backpacks, hygiene kits—and even haircuts and dental care at the Farmington event. Many non-homeless and non-veterans showed up. Both have a "don't ask" policy—no one was or will ever be turned away.

State Extends COVID Booster Eligibility to All Adults

Gov. Michelle Lujan Grisham signed an executive order on November 12 expanding eligibility for COVID-19 booster shots to all New Mexico adults as part of the state's strategy to address rising case numbers and hospitalizations, a trend being seen nationwide.



"As we have throughout this unpredictable and unprecedented global pandemic, we always stand ready to quickly implement new tools and policies in our fight against this terrible disease," said Gov. Lujan Grisham. "I strongly encourage every New Mexican to register for a booster today – we have appointments available and are ready to get shots in arms."

The Centers for Disease Control's eligibility criteria for boosters include adults 18+ who live or work in a high-risk setting.

New Mexico joins other states – including California and Colorado – that have made boosters available to all adults 18+.

"Case counts are significant, spread rates are far too high, and the Delta variant is far more transmissible than previous variants. In addition, our hospitals are well beyond capacity, and several have declared Crisis Standards of Care," said Department of Health Acting Secretary David R. Scrase, M.D. "Those factors absolutely make New Mexico a high-risk setting."

New Mexicans aged 18 and over may now schedule a booster shot if:

- They received the Johnson & Johnson vaccine more than two months ago OR
- They completed the Pfizer or Moderna vaccine series more than six months ago

"Providing boosters for adults will significantly increase levels of immunity protection across our state – and that's essential for all of us. COVID-19 is incredibly opportunistic – and it's our job to ensure that the virus has fewer and fewer opportunities to spread," said Secretary Scrase. "If it's time for you to get a booster, please do so right away."

While the vaccines remain highly effective at preventing hospitalizations and deaths, new data suggests that immunity protection can wane over time – leading to more vaccine breakthrough cases. As immunity protection wanes, the immunized become more susceptible to infection – though their infections are typically much milder than those among unvaccinated individuals.

Health officials also strongly recommend that children 5-17 receive vaccinations. New Mexicans can sign up for initial vaccinations and booster shots at VaccineNM.org. Instructions for scheduling children's vaccinations are also available at https://goodtimes.vaccinenm.org/dependents/

MASK REQUIREMENT EXTENDED

The statewide requirement that face masks be worn in all indoor public spaces, with only limited exceptions and regardless of vaccination status, will also be extended, effective through at least December 10.

Staffed hospital beds remain in dangerously short supply, as primarily unvaccinated individuals continue to spread a more infectious variant of the virus, and several New Mexico hospitals have implemented crisis standards of care.

Health officials, including at the Centers for Disease Control and Prevention, continue to recommend tight-fitting face masks be worn in indoor spaces as they are effective in limiting the spread of the more transmissible Delta variant.

The governor, acting upon the counsel and analysis of the state Medical Advisory Team and state health officials, may decide to extend or lift the mask requirement as necessary. A separate public health order requiring health care workers to be vaccinated and implementing vaccinate-or-test protocols for school workers remains in place. The Department of Health also advises all New Mexicans aged 6 months and older to get a flu shot. Many providers of the COVID-19 vaccine also provide a flu shot. DVS, New Mexico VA Health Care System Urge Veterans to Sign Up for COVID Booster Shots

DVS Cabinet Secretary Sonya Smith urges New Mexico's veterans and their eligible adult dependents to sign up for COVID booster shots—either through the state or the New Mexico VA Health Care System (NMVAHCS.

"As with the initial COVID vaccine, veterans have two excellent options to get the booster shot," said Secretary Smith. "Please—let's not let our guard down against this virus. Let's do our part to keep New Mexico safe."

The NMVAHCS operates a drive-through "Camp Murphy" vaccination clinic at the Albuquerque Raymond G. Murphy VA Medical Center, located at 1501 San Pedro Drive SE.

"Boosters are an important step forward in the fight against this pandemic," said Jean NMVAHCS Interim Medical Center Director Jean Gurga. "Our ultimate goal is to have all veterans vaccinated who want to be vaccinated."

VA Extends Presumptive Period For Gulf War Veterans

The U.S. Department of Veterans Affairs has extended the presumptive period to Dec. 31, 2026 for qualifying chronic disabilities rated 10% or more resulting from undiagnosed illnesses in Persian Gulf War veterans to ensure benefits established by Congress are fairly administered.

If an extension of the current presumptive period was not implemented, service members whose conditions arise after Dec. 31, 2021 would be substantially disadvantaged compared to service members whose conditions manifested at an earlier date.

Limiting entitlement to benefits due to the expiration of the presumptive period would be premature given that current studies remain inconclusive as to the cause and time of onset of illnesses suffered by Persian Gulf War veterans.

VA presumes certain medically unexplained illnesses are related to Persian Gulf War service without regard to cause, including, chronic fatigue syndrome, fibromyalgia, and functional gastrointestinal disorders. Also included are undiagnosed illnesses with symptoms that may include but are not limited to abnormal weight loss, cardiovascular disease, muscle and joint pain, headache, menstrual disorders, neurological and psychological problems, skin conditions, respiratory disorders and sleep disturbances.

Persian Gulf War Veterans who are experiencing any of the symptoms listed above and other unexplained medical issues are encouraged to file a claim. (NOTE; Contact any DVS veterans service officer (VSO) listed on the back pages of this newsletter)

VA Accesses Resources to Increase Housing Assistance to Vulnerable Veterans

VA has updated regulations governing the Supportive Services for Veteran Families grant program to provide a more effective subsidy to veterans in high-cost rental markets and to increase the cap in general housing assistance available to the most vulnerable veteran families.



Under the new regulations, in certain communities, the SSVF grant will cover up to 50%, an increase from 35%, of eligible veterans' reasonable rent for two years without need for recertification.

"We know veterans are increasingly vulnerable to homelessness and housing insecurity," said VA Secretary Denis McDonough. "The updated regulations give Supportive Services for Veteran Families grantees more flexibility and tools to keep veterans housed while also helping them increase their income and access permanent affordable housing solutions."



The new rule also expands the maximum stay in emergency housing for unsheltered veterans.

The original rule authorized placement for a veteran and his or her spouse with dependents in emergency housing for up to 45 days, which proved often not enough time to locate stable and affordable permanent housing in highly competitive rental markets.

A veteran and his or her spouse with dependents can now stay in emergency housing for a maximum

of 60 days. The 15-day increase in length-of-stay is expected to have the most significant benefit to veteran families in rental markets with few vacancies, as well as unsheltered homeless veterans families.

Ending veteran homelessness is a top priority for VA, aligned with the White House's priority to promote housing stability by supporting vulnerable tenants.
