New Mexico Department of Veterans Services Cabinet Secretary to Leave DVS



New Mexico Department of Veterans Services (DVS) Cabinet Secretary Sonya Smith will step down as head of the department on Friday, November 11—Veterans Day.

"I am very grateful to Secretary Smith for her service to New Mexico's veterans and their families while leading the Department of Veterans Services," said Governor Michelle Lujan Grisham, who on November 8 was re-elected for a second four-year term. "I wish her and her family all the best moving forward."

Sonya Smith Outgoing DVS Cabinet Secretary

Under her leadership as DVS cabinet secretary, Secretary Smith supported the enactment of an income tax exemption for armed forces retiree pensions. She also helped successfully galvanize New Mexico's push-back against a nationwide VA proposal to close 700 community-based outpatient clinics—

including four in New Mexico, along with the VA PTSD clinic at the Albuquerque Raymond G. Murphy VA Medical Center.

Secretary Smith also oversaw the DVS launch of the Highly Rural Veterans Transportation Program, which provides cost -free round-trip transportation for New Mexico veterans from 15 counties categorized as "highly rural" to any VA or VA-approved medical appointment. She also increased the number of veterans service officers (VSOs) to the department's highest number ever, increasing ready access to services for veterans throughout the state; reinstated the Women Veterans Program, increasing service to the fastest-growing demographic in military affairs; and estab-



lished a full-time department tribal liaison to better support Native American veterans.

"I'd like to express my deepest thanks to the governor for trusting me to serve New Mexico's veterans. It has been an honor and a privilege to be a member of her administration," said Secretary Smith, who previously worked at the department of health.

"I have loved my many years of service in New Mexico, but I am looking forward to being able to be closer to family, and am excited about this next chapter in my life."

A veteran of the Gulf War, Secretary Smith served as a medical technician in Operations Desert Shield and Desert Storm as a member of the U.S. Air Force Reserve, from which she received an honorable discharge. She earned a bachelor's degree in health services management from Norfolk State University in Norfolk, Va., and a master's in health care compliance from Argosy University.

"I also want to express my appreciation to New Mexico's veterans," she said. "Thank you for your service. America would not be the great nation that we are if it weren't for your sacrifice to serve and protect us.

"And last, but not least, to the DVS family that I've had the privilege of working with—thank YOU for your hard work to make sure that, in New Mexico, *Every Day is Veterans Day*. You make this the BEST state agency in New Mexico. I know you'll continue giving your very best for New Mexico's veterans."







DVS Presents \$8.6 Million Budget to the Legislative Finance Committee

DVS presented its fiscal year 2024 (FY24) agency budget request to the New Mexico Legislative Finance Committee (LFC) on October 19 at the state Capitol in Santa Fe.

DVS Cabinet Secretary Sonya Smith requested an \$8.6 million FY24 budget—an increase of 19.8% from the budget of the current fiscal

year (FY23) which ends June 30 of next year. She testified that the proposed budget is needed to enable the agency to grow and keep up with new challenges to its mandate of serving New Mexico's veterans and their families.

Among the immediate goals and needs for the agency are:

Increase staffing and outreach


- Increase service and outreach to the state's rural areas. Many veterans, particularly those living in
- Native American pueblos and on other tribal land, do not have internet access—which DVS offers as an alternative to in-person office visits for veterans seeking help with their benefits needs.
- DVS also anticipates a rise in VA claims filings by veterans due to the recent passage of the PACT Act. This new federal law allows Gulf, Iraq, and Afghanistan War veterans to file VA medical treatment claims for treatment of health issues linked to exposure to toxic smoke from "burn pits" and exposure to other toxic materials while in service.
- The new law also allows Vietnam War veterans to finally file claims for health conditions linked to exposure to the "Agent Orange" herbicide used by the U.S. military as a jungle defoliant in southeast Asia.

Expand coverage of its existing Highly Rural Veterans Transportation Program

The lack of a reliable transportation options is one of the top complaints by veterans throughout the state—and is cited as a reason why many do not seek medical care.

DVS would like to expand its existing Highly Rural Veterans Transportation Program (HRVTP) offering free round-trip rides to and from a veteran's home and any VA medical appointment.

The current HRVTP is funded by an annual VA grant limiting service to veterans in fifteen counties categorized as "highly rural" by VA (less than seven veterans per 1,000 residents). (continued on next page)



Continue funding of the DVS Honor Guard Program

DVS manages the state's honor guard program--overseeing 40 honor guards that render military honors at the majority of veterans funerals in the state. DVS holds two training conferences every year for these all-volunteer units, and provides a stipend for each funeral performance. The number of funeral services rendered by these honor guards has jumped 150% over the past three years. DVS expects this trend to increase in the coming years, especially with the expected groundbreaking of a Carlsbad state veterans cemetery next summer—with completion expected by late 2024.

"I feel really good about our budget proposal," said DVS Cabinet Secretary Sonya Smith."I think it will allow DVS to not only keep up with our continued mission, but to also allow to expand and take on these expected situations."

DVS, Bernalillo County Sign \$300K Agreement to Restore Historic Cemetery

The Bernalillo County Commission, on a 4-0 vote, approved a one-time \$300,000 appropriation to DVS for overseeing the restoration and help support the Albuquerque Historic Fairview Cemetery.

The cemetery, located at 700 Yale Blvd SE, is the final resting place for an estimated 500 veterans including some who served in our nation's Civil War. It was the city's first public cemetery, but has fallen into a severe state of disrepair since it was closed twenty years ago. To facilitate the transfer of funds, a memorandum of agreement (MOA) has been signed between the county, DVS, and the Historic Fairview Cemetery non-profit group which owns the 17-acre site.

Under the MOA, DVS will oversee the restoration effort, which had been done until now by the non-profit group and volunteer members of the public. DVS, which manages state veterans cemeteries in Angel Fire, Fort Stanton, and Gallup, will:

- build an 18-inch block wall around designated veterans burial areas
- finish the clearing of debris and weeds/overgrown vegetation
- install xeriscape landscaping
- restore and align grave markers for veteran gravesites
- restore the existing "Unknown Dead" monument
- and other restoration projects as needed

DVS is targeting completion for late spring of next year.



Veterans Property Tax Exemption/Waiver Backlog

The DVS state benefits division is currently experiencing a heavy influx of veterans property tax exemption and waiver applications.

As a result, delays from between 30-45 days to process the applications should be expected. DVS is asking for your patience as

staff works diligently to process these applications and sending approved exemption and waiver certificates.

Veterans were able to get assistance from the agencies, as well as free clothing, back packs, footwear, blankets, sleeping bags, and a hot meal.

The October 2022 VSO of the month is Roswell-based VSO Danielle Thompson. In nominating her for the honor, DVS Southeast Region Supervisor Matt Barela highlighted Danielle's willingness to go above and beyond her duty as a VSO.

"Danielle's advocacy for veterans, her ability to build relationships with partners within the veteran network, and her willingness to mentor new members of the team is an asset to the entire agency," said Barela." She is also recognized for her desire to grasp and utilize information to assist her veterans and for her outstanding ability to communicate with veterans and their families. In addition to making sure veterans who are eligible have access to healthcare and disability benefits, she can assist in getting lost medals replaced; tracking down military records; housing and transportation; and ultimately burial and survivor benefits."

Barela added, "as a Navy veteran, Danielle knows of the difficulties she and other veterans may have in understanding and accessing benefits. She sees it as her purpose to make sure her fellow veterans receive the services and benefits to which they are entitled."

"Danielle has showed incredible empathy, compassion and knowledge in the CVSO services that she provides to the veterans in her area," said Director Wilson. "She is offers ideas and thoughts that improve morale within the agency and takes a mentoring approach to new staff. She seeks to increase her personal knowledge of VA and state benefits and shares what she learns with all staff."

A Brief History of Veterans Day

Although World War I officially ended with June, 28, 1919 signing of the Treaty of Versailles, fighting ceased seven months earlier after an armistice between the allied nations and Germany commenced on the eleventh hour of the eleventh day of the eleventh month—11 a.m. on November 11, 1918. In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day. Armistice Day was set aside to honor veterans of World War I.

But after World War II, which required the greatest mobilization of soldiers, sailors, marines, and airmen in the nation's history, a World War II veteran from Birmingham, Alabama, Raymond Weeks

(right photo/in dark suit) had an idea to expand Armistice Day to celebrate all veterans.

In 1947 he led a delegation to Washington, D.C., to urge then-Army Chief of Staff General Dwight Eisenhower (*photo/at left*) to create a national holiday that honored all veterans. In 1954, President Eisenhower signed legislation establishing November I I th as Veterans Day.

President Ronald Reagan honored Weeks as the driving force

t

for the national holiday with the Presidential Citizenship Medal in 1982 at the White House. Weeks

led the first National Veterans Day Parade in 1947 in Alabama, and he continued the tradition until his passing in 1985.

Doors open at 7:15 a.m. for conference and free raffle registration. Complimentary self-serve pastries, coffee, and juice will be available. Lunch will be served at 12:30 p.m., with the symposium concluding at 4 p.m.





Veterans Enrolled in VA Health Care Now Eligible for New Toxic Exposure Screenings

VA medical centers and clinics across the country are now offering VA health care-enrolled veterans a new toxic exposure screening.

These screenings are a key part of the <u>PACT Act</u>—the new law that empowers VA to deliver care and benefits to millions of

toxic-exposed veterans and their survivors. The screening takes around five to 10 minutes and begins by asking veterans if they believe they experienced any toxic exposures while serving in the armed forces. Veterans who answer "yes" will then be asked about specific exposures, including open burn pits/ airborne hazards, Gulf War-related exposures, Agent Orange, radiation, Camp Lejeune-contaminated water exposure and other exposures. Veterans enrolled in VA health care will be offered an initial toxic exposure screening then follow-up screenings at least once every five years.

"These screenings are an important step toward making sure that all toxic exposed veterans get the care and benefits they deserve," said VA Secretary Denis McDonough. "At the end of the day, these screenings will improve health outcomes for Veterans — and there's nothing more important than that."

After completion of the screening,VA will connect veterans who are concerned about toxic exposures to information about benefits, registry exams and clinical resources. Medical concerns will continue to be addressed through existing care teams or other facility resources as appropriate. Veterans can ask about receiving the screening at their next VA primary care provider appointment. If veterans are not assigned to a primary care team or wish to be screened sooner than their next appointment, they are invited to contact their local facility and ask to be screened by the toxic exposure screening navigator.

On September 6,VA began a pilot of this program — screening 13,380 Veterans across 12 medical centers over a 2-week period and finding a 37.4% concern of exposure among those veterans.VA encourages veterans not currently enrolled in VA health care to apply now. VA Program of Comprehensive Assistance for Family Caregivers Expands to Veterans of All Eras

VA has expanded its <u>Program of Comprehensive Assistance for</u> <u>Family Caregivers</u> to include <u>eligible</u> veterans and family caregivers of all eras.

Previously, PCAFC was only available to eligible veterans who served on or after Sept. 11, 2001. This expansion opens the

program to eligible veterans of all eras, including those who served after May 7, 1975, and before September 11, 2001.

PCAFC provides caregivers of eligible veterans with resources, education, financial assistance, health insurance, beneficiary travel, peer support and more. The program is a cornerstone of VA health care, ensuring that veterans get the world-class care they deserve and that caregivers get the comprehensive support they need.

"For the first time, eligible veterans of all service eras can participate in the VA's Program of Comprehensive Assistance for Family Caregivers," says Deputy Secretary of Veterans Affairs Donald Remy. "We recognize the critical role family caregivers play in caring for veterans, and through this expansion, we're able to ensure that family caregivers of all eligible veterans have access to the comprehensive support they deserve."

> This is the second expansion of PCAFC, and it will expand access to the program for tens of thousands of veterans and their family caregivers. The first expansion of PCAFC began in Oct. 2020, as part of implementation of the VA MISSION Act of 2018. PCAFC has added approximately 20,000 active veteran and family caregiver participants during the past two years.

Earlier this month,VA announced an interim final rule that will extend PCAFC eligibility for legacy participants, legacy applicants and their family

caregivers, by three years to Sept. 30, 2025. Legacy participants or legacy applicants are veterans and their family caregivers who participated in PCAFC prior to Oct 1, 2020.

New VA Life Insurance Program to be Offered by VA

Important changes are coming to VA's Life Insurance programs. <u>Veterans Affairs Life</u>

Insurance (VALife) is launching on Jan. 1, 2023, as



a new guaranteed acceptance whole life insurance program for service-connected veterans. VA's current offering for service-connected veterans—service-disabled veterans life insurance (S-DVI)— closes to new enrollment after Dec. 31, 2022. Veterans currently enrolled in S-DVI may keep their coverage or switch to VALife.

While both VALife and S-DVI cover veterans with any level of service-connected disability (0-100%), there are key program differences to consider before deciding which program is right for you.

So, What is the Difference Between VA Life Insurance and Service-Disabled Veterans Life Insurance?

Coverage amounts

- VALife offers up to \$40,000 in coverage, available in \$10,000 increments.
- S-DVI offers up to \$10,000 in basic coverage. Up to \$30,000 in supplemental coverage is available only if you are totally disabled, unable to work and qualify for a premium waiver.

Premium waiver

- VALife does not offer a premium waiver option.
- S-DVI offers a premium waiver if you are totally disabled and unable to work.

Premium amount

- VALife premium rates are based on age and coverage amount. Once your VALife policy is issued, premium rates do not increase.
- S-DVI premium rates are based on age, coverage amount and coverage plan.

Medical requirements and waiting period

- VALife does not require you to answer health questions for enrollment. Because of this, there is a two-year waiting period for full coverage to begin, a common feature of guaranteed acceptance whole life policies.
- S-DVI requires proof of good health, other than your service-connected condition(s), prior to enrollment. Once enrolled, there is no waiting period for coverage to begin.

Application timelines

- VALife has no time limit to apply if you are age 80 and under. Veterans age 81 and older may qualify if they meet certain criteria.
- S-DVI requires application within two years of receiving notification of a new service-connected disability rating, or by December 31, 2022, whichever comes first.

VA Closes Gap in Benefits for LGBTQ+Veterans and Their Survivors

VA has announced it is closing a gap in survivor benefits for certain survivors of LGBTQ+Veterans specifically, for those who were unable to wed until the <u>2015</u> Obergefell v. Hodges Supreme Court decision, and

who, therefore, were not married to their now-deceased Veteran spouses for long enough to qualify for survivor benefits.

This extension of survivor benefits is effective immediately. Eligible survivors can apply for these benefits <u>here</u>, and more information about this announcement can be found <u>here</u>.

"VA is closing a gap in benefits for surviving spouses of LGBTQ+ veterans, righting a wrong that is a legacy of the discriminatory federal ban on same-sex marriages," said VA Secretary Denis McDonough. "It is VA's mission to serve all veterans – including LGTBQ+ veterans – as well as they've served our country, and this decision is a key part of that effort."

Due to bans on same-sex marriages, many LGBTQ+ veterans were unable to get married until Obergefell v. Hodges (6/26/2015) despite being in "marriage-type" relationships long before that. This wrongly precluded many survivors of those LGBTQ+ veterans from becoming eligible for <u>survivor</u> <u>benefits</u> because their veteran spouse died before the marriage met VA's length-of-marriage requirements (one-year for <u>survivor benefits</u>, eight-years for a higher rate of benefits).

This decision addresses that problem by counting the duration of marriage from when the surviving spouse can establish a "marriage-type" relationship — such as a commitment ceremony, joint banking account, or joint purchase of a house. Importantly, these benefits are not retroactive.

VA is committed to delivering world-class care and benefits to LGBTQ+ veterans. As a part of this effort, last year, <u>VA began providing benefits</u> to veterans who were given "Other Than Honorable" discharges due to their sexual orientation.
